STEPS FOR VOTING

- 2. Find your sample ballot to see what races and ballot measures will be on it:

3. Research the candidates and ballot measure topics by using this Voters Guide, online at VOTE411.org, or using any other method you want.

- 4. Print your sample ballot, this *Voters Guide*, or your VOTE411.org printout, and mark your selections. If you don't have a printer, you can write down your selections on a piece of paper.
- 5. Take your ID and your printout with your selections to a polling location during Early Voting or on Election Day. What IDs are allowed:

- 6. Walk up to the reception desk at the polling location and show your ID. They will ask you to confirm you still live at your registered address, then you'll sign your name to get an empty ballot.
- 7. Take your empty ballot, walk over to an open voting machine, slide your ballot into the machine, and use the touchscreen to make your selections (you can use your printout with your selections as a reference).

NOTE: Using electronic devices (e.g., mobile phones) at polling locations is prohibited (this is why you should bring a paper with your selections).

8. When you're done, print your completed ballot, review your printed selections, walk over to the ballot box, and slide your completed ballot into the ballot box.

Congratulations! You voted! Take an "I Voted" sticker and wear it proudly!



- **3.** The candidate must qualify for the ballot in enough states to win a majority of electoral votes.

Democracy: Texas is sadly one of the hardest states to vote in. As a former voting rights attorney, I have seen firsthand the devastation on the faces of Americans when they are disenfranchised. I'm

committed to ensuring that it is easy and safe for all eligible Americans to vote in our elections, which is why I have been a proud cosponsor of the John Lewis Freedom to Vote Act. Immigration: My mom was raised in Brownsville where I often spent summers visiting my grandmother. I support comprehensive reform that includes securing our border, reforming our asylum process, protecting Dreamers and providing a pathway to earned citizenship and matching our immigration system to the needs of our economy. I am a cosponsor of the bipartisan Dignity Act, and the Bipartisan Border Bill.

Cost of Living: I was raised by a single mom and it wasn't always easy. I know what it is like when costs go up. I was proud to champion legislation to lower health care and energy costs and cap the cost of prescription drugs and insulin for folks on Medicare. We also must cut the cost of child care, work towards universal pre-k and establish nationwide paid family and medical leave.

Reproductive Rights: My wife and I were blessed to have two healthy boys in Dallas, and I cannot imagine if the doctor at one of those appointments had said that something was wrong with our baby but there was nothing they could do about it because of Texas' abortion ban. Among the first pieces of legislation I plan to support is the Women's Health Protection Act, which will codify Roe v. Wade as the law of the land.

Climate Change: We can address the climate crisis, lower energy costs and incentivize economic growth simultaneously. We need an all-of-the-above energy approach that keeps costs low, creates jobs and strengthens our grid. For the last hundred years Texas has been an energy leader and I will continue to support responsible oil and gas production as well as our fast-growing wind, solar and hydrogen sectors. **Freedom of Speech:** Protecting the freedom of speech is paramount, as that freedom is foundational to other freedoms. The government has a role to play in ensuring that this freedom is protected from bad actors and foreign adversaries. The rise of disinformation is incredibly concerning, and we must put in place guardrails and ensure our social media platforms counter harmful disinformation. **International Relations:** These core values are not in tension. Smart trade policy is great diplomacy. This is one of the reasons I championed the USMCA agreement, to strengthen labor standards and grow our own economy with high-paying jobs. By creating trade agreements with other democracies, we can strengthen our own prosperity and independence while standing up to bad actors with a multilateral approach.

Government should not get between women and their doctors on a completely personal decision about their own reproductive systems. I support a federal law to protect access to abortions nationwide, since so many red states (like Texas) want to limit women's personal choices.

Climate Change: While climate change is happening, most proposals to counter it will do little or nothing to actually lower temperatures. Instead, the proposals want to damage Western economies while ignoring China's major emissions. We need a free market in energy, without government subsidies or controls. If we want less carbon emissions, we need to build more nuclear power plants, which have no emissions. Freedom of Speech: I am a 1st Amendment free speech absolutist and oppose any government attempts to limit free speech. Government should never decide what information is accurate or true, since they are likely covering up their own misdeeds. Both my opponents want to ban Tik Tok. I say no to censorship. The solution to bad speech is more speech. We also have to protect Section 230 from any more attacks. Kristin Hook (D)

Background/Experience: I am not a polished politician. I grew up in a workingclass family in Texas. Against all odds, I earned two degrees from UT-Austin and a PhD from Cornell. When the pandemic

hit, I left my research career in reproductive biology to serve the public as a science & tech expert in our federal government (U.S. Senate, NIH, GAO). As a scientist and former teacher, I am trained to solve problems and will bring sensible leadership and compromise to Congress to help solve the critical issues we face.

I've spent most of my career as an educator, scientist, and public servant. I served the public as a middle school teacher through Teach For America and as a science and tech expert in our federal government. I also spent ten years as a reproductive biologist, proudly earning my PhD despite being raised by a single mom who never went to college. Reproductive Health: As a woman, I believe we should have the freedom to make our own reproductive healthcare decisions. I support protecting and restoring Roe v. Wade and expanding access to birth control, IVF, and reproductive medicines. I believe family planning decisions should be made by patients and medical experts, not politicians or government. I trust Texans to make their own reproductive health decisions and believe you and your doctor are smart enough to make the best decisions for you and your family.

Immigration: Growing up near the border, I'm dedicated to supporting bipartisan solutions for the border crisis and fixing our immigration system. To curb illegal crossings and address safety concerns, I support enhancing border security and enforcement, improving case processing, and addressing the root causes of migration. Additionally, I will advocate for new legal pathways to citizenship, especially for Dreamers and hardworking immigrants who contribute to our society and economy while obeying the law.

U.S. Supreme Court: When I served as a scientist at the Government Accountability Office, I took an oath of loyalty to our Constitution, which outlined a system of government with checks and balances. No branch of government should be responsible for policing itself, and no one in public service should hold a position for life. Thus, I support instituting term limits and legislation that strengthens the impartiality and ethical integrity of the federal judiciary, including a binding and enforceable code of conduct.

Economic Policy: I grew up living paycheck to paycheck and understand the strain of rising costs. I believe to build a stronger America, we must ensure a fair economic system for all by strengthening the middle class and abolishing poverty. Thus, I support protecting Social Security, raising the minimum wage, paid family and sick leave, access to affordable childcare, tax reform so billionaires and corporations pay their fair share, empowering workers' rights to organize, and bolstering small business owners.

Electoral College: I believe in fair representation and that the presidency should be decided by the candidate who receives the most nationwide votes. Under our current system, the presidency is decided by the Electoral College, which dilutes the power of voters based on where they live. I support reforms to the Electoral College that would make presidential elections more democratic. A national popular vote would help ensure that every voter counts equally and would make the U.S. a more representative democracy. **Guns:** I come from a family of responsible gun owners and hunters. Like them, I support common sense gun safety laws that protect the Second Amendment. I will work across the

aisle to pass evidence-based legislation that keeps Texans safe while supporting responsible gun ownership, such as expanding background checks, licensing laws, waiting periods, red flag laws; restricting bump stocks; and raising the age for gun purchases and possession.

Bob King (L)

Background/Experience: I have had the privilege of having two distinct careers: the first, from 1983-2004, as a banker and then as a senior financial executive in the oil and gas industry; the second, from

2004-2020, as a nonprofit executive and consultant. I also have more than 40 years of experience as a taxpayer.

I have a BA in Economics and an MBA in Finance, both from SMU in Dallas. I worked for 20 years in the energy finance industry, and another 15 as a nonprofit leader, board member and consultant. The financial background gives me an understanding of markets and of budgeting and accounting; the nonprofit background (plus my Christian faith) taught me that society must assist the neediest among us. I also have 40+ years experience as a taxpayer, so I know that money doesn't grow on trees.

Reproductive Health: Abortion policy should be a balancing of rights, with the presumption in favor of choice, at least until the fetus is equipped to survive outside of the womb. Therefore, abortions should be legal until the 20th week of gestation; the States should be able to regulate them if they choose ONLY after week 20. Tax dollars should NEVER be used to pay for abortions. All contraception choices and IVF should remain legal. The two parties do not seek a solution. I do. See my website for more.

Immigration: Border security comes first, but we need more legal immigrants. Let's (1) tighten rules for asylum, (2) grant legal status to Dreamers, (3) create a guest worker program, and (4) simplify/increase green cards granted to workers and college grads. Then, defer implementation of these liberalizations until violations of our border are under control. This approach gets both sides paddling in the same direction. The two parties do not seek a solution. I do. See my website for more.

U.S. Supreme Court: The Supreme Court is the only branch of government that defends our liberties. Congress passes laws restricting our freedom and redistributing our money; the President takes us to war without constitutional authority and regulates us to death. Only SCOTUS stands in their way. 

Oil and Gas Wells: The RRC needs to continue to monitor plugged and abandoned wells in perpetuity. They need to take responsibility for all old wells in the state, whether they were drilled for production or water and they need to hold the companies that drilled the wells responsible for continuing to monitor and confirm the integrity of the well plugs and repair leaking or damaged wells to protect our communities.

Emissions: Flaring releases methane (natural gas) and other hazardous air pollutants and contributes to ground-level ozone. RRC needs to update Rule 32 to define when a flaring permit should be granted, remove flaring applications from the consent agenda, and hold companies accountable for the

environmental damage they are doing to all of us. They have only denied 44 out of >8000 permits since May '21. Carbon Capture: No, CCUS presents new risks to drinking water from harmful materials like lead, arsenic, and strong acids. The RRC is not funded to allow adequate oversight of this new technology, which is not fully developed, adding more complexity. The RRC is unable to control the oil, gas, and injection wells that are already under its control, we should not add more to further put our communities at risk. Seismic Activity: The limits the RRC are putting on the injection wells are not working. We need to further limit the number of injection wells and the locations by not injecting disposal water near natural fault lines. Additionally, we need to hold the companies accountable for treating the water so it is not toxic and can be reused elsewhere.

Ethics: There is a difference between receiving income from working in an industry and making windfall profits from corporate investments with the companies you are regulating, having your actions directly increase your profits. Many agencies prohibit investments in companies that are affected by agency actions and Texas needs to implement the same rules. Industry experience is an asset for regulators. Ethics: It is standard for lawyers who practice in courts to donate and support judicial races. They just want good judges who will make decisions either way and let them try their case. Even after 5 1/2 years on the bench, ruling for and against these lawyers, I am honored to still have their support because they know I am just doing my job and will be fair. It will be the same on the Supreme Court. Equity: There needs to be greater efforts made to educate the public about the numerous services available. Between non-profit organizations, pro-bono legal services, legal clinics at the law schools, there are so many opportunities for free or low-cost legal assistance that most citizens do not know about. There needs to be an investment made to publicize the efforts of these organizations to citizens.

Judicial Elections: The judicial canons prohibit candidates and judges from talking about their position on crucial issues the voters want to know about. For example, I can't tell you my position on abortion or election reform because those kind of cases come before the Court. This oath requires that we set aside any outside influence and follow the law. It is a solemn responsibility. I have been honored for my professionalism and integrity throughout my career.

PRESIDING JUDGE



David J. Schenck (R)

Qualifications: I served for 8 years as an appellate justice, chaired the state's judicial conduct commission and have specialized in appellate work for 30 years. I served also as Deputy Att'y General

Ethics: Please see my website and my 2005 U.S. Supreme Court brief in Dimick. This has been a core concern of mine for 2 decades and why I have called for reforms, including limits on contributions, immediate disclosure when made during a case and mandatory recusals depending on the amounts and timing.

Judicial Elections: We would have judges selected with the assent of far fewer voters and perhaps (but by no means certainly) less allegiance to the parties. Municipal elections are non-partisan and yet people still figure out which mayoral candidate is aligned with which party. Local (county wide) judicial races might be different, but statewide races will always attract heavy attention/spending, etc..

Equity: I think the issue here is more about quality of access than quantity; people, esp. the wealthy and very poor) can get to court on their own or via programs to provide counsel but everyone (not just the underserved) need meaningful access. It's the middle class that is really under served here. In civil cases, we have rules to expedite cases but few judges are aware of or adhere to them.

Philosophy: Simple: follow the law, don't make it up and treat everyone fairly.



Holly Taylor (D)

Qualifications: I have practiced criminal law for over 25 years as a prosecutor and as an attorney for the Court of Criminal Appeals. I have been an adjunct law professor and I worked to remedy

wrongful convictions.

Ethics: Our Code of Judicial Conduct requires judges to perform their "judicial duties without bias or prejudice" and avoid "the appearance of impropriety." Judges should recuse themselves in cases where their "impartiality might reasonably be questioned." I will recuse myself in any case that I worked on as a prosecutor and in any case where they could be an appearance of impropriety.

Judicial Elections: The Code of Judicial Conduct bars judges from taking a position on political issues. Commentators have said that nonpartisan judicial elections would allow judicial candidates to maintain the appearance of impartiality. Others have insisted that voters should have the right to know the party affiliations of judicial candidates. This is an issue for the Legislature.

I am not influenced by donations to my campaign. The Texas Code of Judicial Conduct ensures that judges who break campaign finance laws are sanctioned by the State Commission on Judicial Conduct.

Judicial Elections: Unlike appellate judges trial judges have a discretion to order rehabilitative/mental health services for defendants in need, and punitive prison sentences for violent dangerous criminals. Democratic judges are known to strike a healthy balance between rehabilitation and punishment, unlike their conservative counterparts. For this reason, voters need to know a trial judge's political affiliation.

Equity: Judges should come to work timely, appoint competent attorneys to indigent defendants and translators for non-English speakers. Low level offenders should be released quickly with low or PR bonds and only come to court when their case is set for disposition. Cases should not be set far out to ensure timely justice. Probationers should report to nearer offices and conditions that help them succeed. **Philosophy:** I believe our laws should be interpreted strictly according to the legislative intent, not colored by the judge's individual biases or prejudices. A1: More than \$3 billion dollars have been allocated to Operation Lonestar to pay for a military presence at the border and to transport migrants to other states, both of which are short-term solutions. It has also

funded 34 miles of a wall along the 1,254-mile Texas border, which will take decades to complete. A significant portion of this money should be spent on additional judges and asylum officers to help clear the backlog of cases, more border patrol officers to expedite current processing, and support for the Southwest Border Coordination Center that works with federal, state, and local entities to help manage immigration. **A2:** As a retired school principal, public education is very important to me. Funding for public schools has not kept up with inflation for years, ranking Texas 43rd in the nation for per-student funding. Vouchers will make the issue worse by funneling millions of taxpayer dollars to students who are already attending private schools. I will not support vouchers because public funds must stay in public schools. I will also oppose any effort to embed religion in public schools beyond curriculum that is designed to teach multiple religious doctrines equally and is aligned with state curriculum standards. **A3:** Girls and women in Texas are not free citizens because they do not have control over their own bodies. I was a secondary Social Studies teacher, as well as a guidance counselor and school administrator, in public schools. **History Education:** Many states have moved away from standards that focus heavily on specific historic events to focus more on social studies skills and analytic abilities. I believe it is important to look at these models, which often have a more inclusive view of U.S. and world history to include the stories of various communities, which I would advocate for, along with centering analytic skills.

Religion in Public Schools: Separation of church and state has been a foundational part of the United States government and is upheld by the first amendment to the constitution. The first amendment prohibits the establishment of a national religion. It is clear that the promotion of a single religion within public schools would be unconstitutional. Religions can be taught in a historical context, but not in a moral context.

Teacher Certification: I believe that all teachers should have to be certified in order to teach. Certification programs provide essential training in child development and peda-

gogy, which is necessary for becoming an effective educator. I do believe that emergency licensure should continue in allowing teachers temporary certification while they are completing any necessary requirement for a certification program.

Other Issues: I believe another key area that is important within the State Board of Education is ensuring that charter schools are held to a high standard, particularly in ensuring that they are able to meet the needs of students with IEPs and 504s, along with emerging bilingual students. **Campaign Website: drsofortexas.com**

Ethics: Donors give because they like what the candidate says (or implies) about their judicial philosophy. People who give to candidates who run on diversity and identity are not impacting how those candidates approach the law. They are enabling it.

Judicial Elections: Partisan races are a big problem for

courts in large, blue cities. It encourages under-qualified people to run with the hope that winning a short, lowturnout Democratic primary will lead to an easy victory in November. That has largely been the case in recent elections. Everyone suffers when that happens.

Equity: I am aware of no one who is denied access to the courts. If "access to justice" means a better court experience, the best way to serve everyone—not just selected groups—is to elect judges who understand the law and apply it fairly. No amount of money for appointed lawyers will help underserved people who go before ignorant or biased judges.

Court System: Specialty courts should enhance the efficiency of the justice system in two ways. First, the people on those courts should be experts who can more quickly and correctly dispose of cases. Second, reducing the workloads of the other courts should result in their remaining cases being decided more quickly. That is, if we elect people who know what they're doing.

Maggie Ellis (D)

Qualifications: I have handled thousands of cases and hearings in court as a judge, a civil, criminal, and appellate prosecutor, and as an attorney representing individuals in five of the counties this court serves.

Ethics: Experience working on cases from all sides is a good indicator of a candidate's likeliness to be fair and impartial. I have handled thousands of cases from all sides, including: presiding over cases as a judge; defending individuals at risk

of losing their liberty, their children, and their homes; and advocating for justice as a prosecutor in cases such as murder, robbery, and sexual assault.

Judicial Elections: While some voters may wish to elect judges who share a similar political ideology, as in a partisan system, the administration of justice should be the same, whether a judge is elected in a partisan or nonpartisan race or appointed. It is critical that judges remain fair and impartial in their decisions. A nonpartisan race should not affect a judge's duty to see that justice is done.

Equity: I will bring my lived understanding of growing up transient and homeless to this bench. With about 15% of Texans living below the poverty level, access to justice is crucial. I have been awarded for my work helping our most vulnerable have access to and be successful in the court system through drafting legislation, establishing pro bono clinics, and advocating for the use of remote hearings.

Court System: These courts will remove voter input within local jurisdictions and will remove the ability to have cases heard by local and regional justices. The judges of the business courts are appointed by the governor rather than elected, and the justices of the 15th Court of appeals will ultimately be elected statewide rather than district-wide like the current appellate courts.

PROPOSITION A

Ballot Language

Approving the ad valorem tax rate of \$0.344445 per \$100 valuation in County of Travis for the current year, a rate that is \$0.025 higher per \$100 valuation than the voter-approval tax rate of County of Travis, for the purpose of increasing access to affordable and high-quality child care and afterschool/summer programming and related services for lowincome families and developing and administering related workforce and economic development programs. Last year, the ad valorem tax rate in County of Travis was \$0.304655 per \$100 valuation.

Explanation

This ballot referendum proposes a tax rate increase to expand access to early childhood care and after-school and summer services for low-income residents. The childcare situation in Travis County is dire.

 Average annual cost of childcare is \$13,000, the highest in the state.

- 2,000 children under the age of three in low-income families need child care right now.
- People wait approximately two years to access affordable child care.
- Options available to parents whose schedules are outside of the 9-to-5 workday are extremely limited.

The money raised would go toward increasing the number and quality of childcare providers, providing scholarships to families in need of assistance, and incentivizing businesses to offer childcare stipends to their workforce. It would also

help current childcare providers survive the loss of federal pandemic funds in 2026. The program will be overseen by a contractor(s) that would procure more childcare providers. The majority of eligible children are residents of the City of Austin. Equitable distribution of funds throughout the County will be determined before the program is launched.

This tax rate election would raise almost \$75 million for Fiscal Year 2024-25. The tax increase would amount to about \$123 annually for the average homeowner. This would be in addition to their roughly \$162 property tax bill (\$285 total).

PROPOSITION P

Ballot Language

Shall an untaxed area in the City of Austin's extraterritorial jurisdiction, containing 35 lots on approximately 96.9 acres of land on Menchaca Road south of Slaughter Lane, be released from the City of Austin's extraterritorial jurisdiction and into unincorporated Travis County, with the result that the Area will no longer be governed by the City's environmental and development regulations?

Explanation

A change in Texas state law in 2023, offered the opportunity for individuals in a City's Extra Territorial Jurisdiction (ETJ) to call for an election for voters to decide future status. If passed, the property would no longer be in the City of Austin's ETJ. It would revert to being in unincorporated Travis County. Under the new law, a validated citizen petition was presented to the City, calling for the removal of the outlined 96.9 acres from the City of Austin ETJ. That territory will revert back to unincorporated Travis County status if approved. The petition was signed by three (3) individuals, with only two (2) of them valid. According to the City Clerk's Election Office, five percent of the registered voters in the area were required to sign the petition to be able to request the measure be added to the ballot. In this case, only one (1) valid signature was required to request the election question and that satisfies the requirements.

ONLY residents in the 96.9 acres are allowed to vote on this ballot question.

LOCAL CITY OF BEE CAVE

PROPOSITIONS

Background

What is a Charter? A municipal charter is a legal document that establishes a town and defines its powers. Think of it like the constitution of the city. On August 13, 2024, the Bee Cave City Council adopted Ordinance No. 539 ordering a special election in the City of Bee Cave, Texas concurrent with the election of the City Council. Most of the propositions pertain to changes in the functioning of the Mayor, City Council and staff members.

PROPOSITION A

Ballot Language

Shall sections of the City Charter be amended to consolidate provisions regarding altering boundaries of the City of Bee Cave through annexation and disannexation?

Explanation

The City Secretary maintains the correct and complete description and official map of the city boundaries and limits. If Prop A is adopted, the City Council shall have the power by ordinance to set the City boundary limits and acquisitions of additional territory, as well as disannex property. The amendment declares annexed property shall be part of the city for all purposes and bear its pro rata part of taxes levied. Property inhabitants will be entitled to all rights and privileges of all citizens and bound by acts, ordinances and resolutions of the City. As the title implies, it consolidates the annexation and disannexation policies and eliminates Charter Chapter Subsection 1.03. Disannexations.

PROPOSITION B

Ballot Language

Shall sections of the City Charter be amended to allow adjustments to compensation of Mayor and Council by ordinance only submitted to voters?

Explanation

If Prop B passes, any future increases in Mayor or City Council compensation may only happen if set by ordinance approved by City Council and be submitted to the voters for approval during a uniform election date.

PROPOSITION C

Ballot Language

Shall sections of the City Charter pertaining to duties and responsibilities of specific officers be amended and to au-

thorize the mayor to sign only specific contracts unless otherwise directed by counsel and other signatory obligations if the city manager is unable; clarifying mayor's authority during emergency or disaster; providing for election of mayor by plurality; authorize the city manager to appoint interim officers until council confirmation, conduct financial and operational audits, assign subordinates to assist mayor and council with official schedules and official communications only; prevent interference with city manager performance; establish city secretary as a city manager subordinate except for agenda formation and elections; establish municipal court as a court of record to clarify jurisdiction with state law; provide for associate judges, and all judicial terms; and clarify the city attorney as the attorney for the city as a whole and as the municipal court prosecutor, require reporting from other legal counsel, and authorize City Attorney to designate special counsel and special prosecutors?

Explanation

Proposition C makes the following changes in the Charter regarding several City officers' duties and responsibilities including municipal court.

If passed, the duties of the Mayor will be amended:

- The Mayor shall sign all contracts or conveyances approved by the City Council.
- The Mayor may sign bonds, warrants, and any other obligations issued in the event the City Manager is unable to perform such a task.
- In case of emergency or disaster, the Mayor shall have the power to enact emergency measures in order to enforce the laws of the City, or to avert danger, or to protect life or property, including but not limited to a case of riot, outbreak, calamity.
- The Mayor shall proclaim the emergency and shall utilize such powers and authorizations allowed by local, state and federal law needed to keep the peace and respond to such emergency.
- The Mayor shall be elected by a plurality of the vote, the same as City Council. [Note: "Plurality" means there are no run-off elections; the person with the most votes wins the office.]

If passed, there will also be changes related to staff duties and Council interaction with staff:

There are a range of very specific actions that will be required of the City Manager and the interaction with the Mayor and Council members. Most changes offer greater autonomy to management, others establish rules of engagement between the Manager and elected officials. If passed, the City Secretary would be a subordinate to the Manager for work other than setting the agenda or elections. The City Secretary would no longer be able

to name an interim City Secretary in the Secretary's absence.

Pertaining to Municipal Court Judge:

If passed, Municipal Court "Associates" must also meet the requirements for the Judge of Municipal Court. The changes will direct the municipal judge, alternates and associates have terms concurrent with the term of Mayor.

Pertaining to City Attorney:

There are several changes in the expectations for City Attorney responsibilities, including representation of the entire City Council; reviewing and approving as to form all documents, contracts, resolutions, ordinances, and legal instruments; and oversee all legal counsel working for the City. Additionally the City Attorney would be the designated attorney for the state in municipal court and any designated prosecutors hold such positions subject to City Attorney's direction.

PROPOSITION D

Ballot Language

Shall sections of the City Charter regarding finances be amended to clarify auditor obligations and repeal provisions pertaining to failure to adopt a budget to be consistent with State Law?

Explanation

If passed, the Charter language on what to do if the City fails to adopt an annual budget will be removed, as State Law covers that possibility.

PROPOSITION E

Ballot Language

Shall sections of the City Charter pertaining to certain administrative provisions be amended to allow additional media for notices and to clarify notices and liability limits for claims against the City?

Explanation

Prop E adds additional media as alternatives for publication of official documents. If passed, the traditional "newspaper of record" will allow the use of additional media. If passed, Prop E also changes the amount of time an injury claim against the City can be accepted for consideration. A claim must be filed within six months after the damage is alleged. It also explicitly states that no City-owned property shall be subject to garnishment or execution of any kind or nature except as provided by state law.

PROPOSITION F

Ballot Language

Shall sections of the City Charter pertaining to petitions and charter amendments be amended to allow additional time for certification, clarify applicable state law, permit non-substantive organizational and corrective revisions to the charter by ordinance, and provide procedures for charter amendments by petition?

Explanation

If passed, once a citizen-filed petition calling for charter amendments is filed, the time period for the City Secretary to determine it the petition is valid would change from five days to twenty days. How signatures would be checked would also change using different State Law guidelines than currently in place. The State Law method for checking signatures would change and provide the opportunity for Council, by ordinance, to renumber and rearrange all articles, sections, and paragraphs of the Charter, or create and adjust the table of contents, or correct grammar or spelling errors. Upon passage of any ordinance caused by a petition, the City will also forward a copy to the Secretary of State for filing.

PROPOSITION G

Ballot Language

An amendment to the Bee Cave City Charter requiring voter approval for the city to take any action or pass any ordinance addressing subdivision, significant physical change or alteration, sale, purchase, donation, exchange, or certain leasing of city real property; requiring all deliberation of such action by the city council or city boards and commissions be done in public, disclosing all conditions and specifics of such proposal; not requiring voter approval of the city purchase of real property but requiring all conditions and specifics of such purchase be disclosed in an open meeting.

Explanation

The proposed Proposition G resulted from a citizen's petition by a group known as "Bee Cave Vote to Amend." The intent of Prop G is to force City Council discussion at an open meeting with the public in attendance about any Cityinvolved property sale, donation, exchange, leasing purchase or physical change. There have been local differences of opinion about the law governing this interaction. If passed, there has been discussion about attaining legal opinions on open meeting laws.

For Maintenance And Repair Of Municipal Streets For Said City

Explanation

If Proposition A passes:

Jarrell has been using funds from the quarter-cent sales tax for street maintenance and repairs since voters first approved the tax in 2009. The city's current proposed budget for street repairs is based on the assumption of a continuation of this revenue. Reauthorization will not increase the sales tax rate in Jarrell. The city will be able to continue using the revenue it produces for street maintenance. If Proposition A fails:

This portion of the sales tax will expire "on the first day of the first calendar quarter occurring after the fourth anniversary of the date the tax was last reauthorized." Texas Tax Code, Section 327.07. The portion of the overall sales tax rate that the city controls (capped by law at 2%) would drop by a quarter percent, to 1.75%, reducing the total sales tax in Jarrell from 8.25% to 8%. With the lower tax rate, the city would lose revenue for road maintenance.

PROPOSITION A

Background

The City of Liberty Hill is currently a General Law City governed by the laws of the State of Texas. General Law cities are restricted to doing what state statutes direct or permit them to do. A specific grant of authority or permission must be provided in the state statutes to initiate a particular action.

Because the City of Liberty Hill has grown to a size greater than 5,000 inhabitants, the Texas Constitution allows the City to establish its own rules for municipal government by adopting a Home Rule Charter. Home Rule cities have the full power of self-government and may take any action in the interest of the citizens' health, safety and welfare that is not contrary to the Texas and U.S. Constitutions or federal or state laws.

Home Rule cities are required to write and adopt a char-

ter that specifically enumerates the structure, power, duties and authorities the people of the community wish to grant their local government.

In the November 2024 election, voters will choose to remain General Law or adopt the charter to become Home Rule.

Ballot Language

The City of Liberty Hill, Texas shall adopt the proposed Home Rule Charter.

Explanation

What this means: Voters will choose to either be "for" or "against" the home rule charter. In general, a home rule charter provides for local control over city governments. The Liberty Hill charter provides for a Council-Manager government, in which Liberty Hill's powers are vested in an elected six-member city council that hires a city manager and is presided over by a mayor. Liberty Hill will have all of the powers granted by Texas, including annexation, public property management, and street regulation. The charter provides for city-related elections processes, how citizens can propose and challenge ordinances, financial accountability, and how amendments to the charter can be made and approved by voters.

If Prop A passes: The City of Liberty Hill will become Home Rule. The proposed charter will be adopted, and all power, duties, structures and authorities defined in the charter will be granted to the local government of Liberty Hill.

If Prop A fails: The City of Liberty Hill will remain a General Law City governed by the laws of the State of Texas, and will continue to be restricted to doing what state statutes direct or permit them to do.

LOCKHART ANNEXATION

Ballot Language

Approving the annexation by the Austin Community College district of the following territory: the territory in the Lockhart Independent School District, and authorizing the imposition of an ad valorem tax for junior college purposes, which is currently set at a rate of \$0.0986, per \$100 valuation of taxable property.

Explanation

Residents who live within the Lockhart ISD (LISD) will vote on the proposed annexation of LISD by Austin Community College District (ACC). ACC will provide programs on LISD property in the evenings and on weekends and will work with LISD to support its development of an Early College High School. Later, with stakeholder involvement, ACC will develop a 15,000-20,000 sq.ft. property located near Lockhart HS as its first facility. Eventually, ACC will purchase land to build a permanent facility.

An ACC campus in Lockhart will decrease commuting time and expenses. If voters approve the measure, residents within the LISD will become part of the ACC district and will be eligible for all in-district benefits:

- Lower tuition rates, possibly free tuition for some high school graduates, home school students and certain GED[®] completers.
- Customized training for local jobs that are in demand now, academic degrees for university transfer, Continu-

ing Education workforce-certificate credentials and entry-level and reentry job-training programs at ACC that take one year or less.

- Access to ACC student support services.
- Voting rights in elections for the ACC governing Board of Trustees.

Voters will have to approve a tax rate increase to pay for the annexation. If approved, homeowners of average value homes would see a monthly increase of about \$19 in property taxes, or roughly \$226 per year. For seniors and disabled residents, the ACC tax levy is frozen at the amount they paid the year they qualified for the additional exemption.



Ballot Language

Ratifying the ad valorem tax rate of \$0.9505 per \$100 valuation in the Austin Independent School District for the current year, a rate that will result in an increase of 8.3 percent in maintenance and operations tax revenue for the district for the current year as compared to the preceding year, which is an additional \$184,628,049.

Explanation

Texas ranks 42nd in the nation in per-student spending. No additional funding to keep up with inflation was approved

by the last Legislature and new unfunded mandates from the State were added to the district's expenses. The situation is grave. AISD estimates that it will have a \$99M budget deficit for the 2024–2025 school year. If Prop A is approved, the budget deficit would be reduced to approximately \$78M. (FAQ - https://www.austinisd.org/propa)

This ballot measure would raise \$171 million total. AISD would use about \$41M in the following ways:

- \$17.3 million to increase teacher and direct service staff salaries.
- \$3.5 million to provide direct instructional and mental health support to campuses.
- > About \$21 million to reduce the deficit.

Texas permits school districts to keep some of the money they raise through taxes. However, some of the money raised by wealthier districts goes to the State to allocate among poorer school districts. This is a complex funding formula and is called recapture. Part of the revenue raised (\$130M) in this election would be subject to recapture by the state. See more about recapture at https://www.austinisd.org /propa.

If approved, homeowners of average value homes would see a monthly increase of about \$34 in AISD property taxes, or roughly \$412 per year. The tax increase does not affect homeowners with an over 65 exemption.

While many other administrative departments have ballooned, LISD is not investing in teachers. Wasteful spending, \$120k for lobbying for example, needs to stop and funds redirected to the classroom.

Student Outcomes: Software spend was \$4M in 2018 and jumped to \$13.5M in 2023. Every digital platform is aligned to Common Core State Standards, despite common core being banned in TX, and all infuse SEL into lessons. SEL allows 3rd parties to collect identifiable student data related to attitudes and emotions and poses a major privacy risk. Moving back to traditional textbooks could potentially save \$94M as well

With issues coming to light with RRISD police, school police forces should be considered cautiously

PROPOSITION A

Background

Liberty Hill ISD has been able to lower its tax rate over the past several years. However, changes in other funding sources are affecting the district's ability to maintain its current level of operations without raising property taxes. The state provides basic funding for public education, known as the Basic Allotment. But the state legislature has not increased this basic per-student allotment since 2019. Meanwhile, inflation has reduced its value. Since 2019, utility costs have increased by 83%; fuel has gone up 176%; and insurance costs have gone up 172%. In 2024, the allotment provides only a little more than 60% of what it currently takes to educate a student.

Additionally, other funding sources the district has relied upon are providing less. The state has capped the amounts available through the Fast Growth Allotment, a funding program that helps districts with rapidly growing enrollments (like Liberty Hill ISD) to keep up with the costs of rapid expansion. Pandemic-era federal Elementary and Secondary School Emergency Relief resources are coming to an end this fall. The district is losing approximately \$900,000 in Medicaid reimbursements for special needs students.

In the face of declining resources, the district has cut \$2 million in expenses by reducing department budgets, increasing class sizes, freezing hiring, reallocating instructional personnel, and cutting administrative positions. Further cost-cutting would involve teacher lay-offs.

Ballot Language

Ratifying the ad valorem tax rate of \$1.226900 per \$100 valuation in the Liberty Hill Independent School District for the current year, a rate that will result in an increase of 21 percent in maintenance and operations tax revenue for the District for the current year as compared to the preceding year, which is an additional \$13,334,196.

Explanation

The purpose of this measure is to increase funding for LHISD's Maintenance and Operations to support the adopted district's 2024-2025 budget without serious reduction to the district's fund balance. The proposal would add 6 pennies to the current tax rate, bringing the total tax rate to \$1.22 per \$100 property valuation.

If Proposition A Passes:

For the school district, passage of the proposition will provide resources to avoid teacher lay-offs and to support a 2% increase in teacher salaries. Keeping salaries competitive helps to attract and retain good teachers. The district will also have funds to protect its instructional and extracurricular programs.

For taxpayers, passage of the proposition will mean an increase in taxes. For a median-value home in the district (valued at \$462,264), the homeowner's tax bill would increase by \$18.11 per month. Homeowners who are over 65 or who have a qualifying disability will not see a tax increase unless they make improvements that increase the value of their homes.

If Proposition A Fails:

For the district, failure of the proposition will mean further cuts, including teacher lay-offs and the reduction or termination of some instructional and extracurricular programs. Teacher salaries will not be increased and the district may experience teacher retention problems.

For taxpayers, failure of the proposition means that their tax bills will not increase.

PROPOSITION B

Background

The Texas Legislature enacted a plan for school finance in 1993 to make funding levels more equal in school districts across the state. The plan establishes "entitlements," which are levels of funding per student, achieved by a combination of state funds and local tax revenue. When a wealthier school district collects an amount of taxes that causes it to exceed its entitlement, the state can "recapture" those excess amounts of locally collected taxes. There are various ways that a school district can pay its recapture bill to the state, but most do so by purchasing so-called "attendance credits." If a district wants to use this method of paying its recapture bill, the voters in the district must approve this in an Attendance Credit Election (ACE).

If voters in a school district do not approve attendance credits to make recapture payments, the state may force the

Answers from candidates who didn't respond by the print deadline may be available online. district to "detach" portions of its tax base and assign them to less-wealthy districts. This means that another, different school district will be selected to collect taxes on the detached property to support its schools. This detachment is permanent. In effect, the original school district permanently loses part of its tax base.

Ballot Language

Authorizing the Board of Trustees of the Liberty Hill Independent School District to purchase attendance credits with local tax revenues.

Explanation

Liberty Hill ISD personnel anticipate that if Proposition A passes and the tax rate increases, the district will need to make recapture payments. In the future, the increasing property valuations in the district would soon bring it to the point of recapture anyway, even without the proposed tax rate increase. This proposal will allow the district to use the Attendance Credit method when that time comes.

If Proposition B Passes:

Liberty Hill ISD can make any mandatory recapture payments it owes using the Attendance Credit method.

If Proposition B Fails:

The district risks having portions of its tax base detached and assigned to another district if it becomes liable for recapture payment. As the Liberty Hill ISD website states, "If the district does not vote to purchase attendance credits, the state can permanently remove some property from LHISD for tax purposes. For example, the state could direct some of the largest businesses in Liberty Hill to pay their school taxes to a different school district, rather than keeping those dollars in LHISD.

Ballot Language

Ratifying the ad valorum tax rate of \$1.0814 in Manor Independent School District for the current year, a rate that will result in an increase of 8.2 percent in maintenance and operations tax revenue for the district for the current year as compared to the preceding year, which is an additional \$6,318,206.

Explanation

MISD asks voters to approve a tax rate increase so the district can raise teacher and direct service staff salaries, hire additional police officers and mental health support staff, and purchase needed equipment and resources. If passed, Prop A will generate \$4.8 million of new funding in 2024-2025 and at least as much each year going forward. None of the money raised would be subject to recapture and all would remain with the district. The \$1.0814 tax rate would be the lowest that Manor ISD has had since 2015. The tax rate change does not affect homeowners with an over 65 exemption.

Offer a competitive salary and benefit packages. **Student Outcomes:** I will advocate for increased funding and seek partnerships with local businesses for providing classroom supplies and continuous professional development for our educators. Ensure essential programs to narrow learning gaps and enhance the accessibility of special education programs. Implement comprehensive safety protocols and ensure that mental health resources are readily available.

School Safety: The state mandated 1 officer/campus by offering < 20k/yr. Many districts cannot pay it out of pocket and seek to delay implementing the rule. I will advocate for sufficient funding from the legislature in 2025 and seek alternative revenues to obtain funds. Ensure sufficient officer coverage for all campuses in the district, and seek coordination from city and county security departments.

PROPOSITIONS

Background

Since April 2024, a Citizen Bond Committee (CBC) worked with Round Rock ISD (RRISD) staff, reviewing suggested projects and the district's Long Range Master Plan. The committee prioritized deferred maintenance as the district's greatest need. The Board of Trustees considered the CBC's findings in called meetings in July and August. On August 15, the Board called for a \$998 million bond election for the November 5 General Election by a vote of 5-2. The proposal is broken into four propositions: General, Technology, Performing Arts, and Athletics.

Board president Amber Landrum acknowledged that the dollar amount of the bond, the district's first in six years, is significant, but pointed out that the proposed projects are necessary. Superintendent Hafedh Azaiez explained the cost by comparing it to owning a home. Items in the home need maintenance and repair. At the end of their lifecycle, they must be replaced before bigger issues develop. "The last thing we want during the middle of the school year is the HVAC to break down and take us a month or two to fix," Azaiez said.

The Board of Trustees is committed to maintaining, repairing, and improving existing infrastructure and facilities and strives for equity, fairness, and impartiality in providing each campus with what is needed to make students successful. All 56 campuses in the district have projects in this bond.

Before approving the bond propositions, the Board discussed their tax implications. RRISD has been fiscally responsible in handling debt, basing its models on conservative growth estimates. The district has made defeasement payments regularly to pay off bond debt early, saving taxpayer interest costs. RRISD has a AAA rating from both Moody's and Fitch. These ratings will allow the district to get good interest rates, though they will be higher than in the past because overall interest rates have increased. Still, assuming moderate growth at 5% in the district's taxassessed value, and a plan to extend the bonds' loan periods to 20 years (rather than 15), the projections show that these proposals will not require an increase in the district's tax rate. In September the Board will consider cutting the Interest and Sinking (I&S) tax rate by one cent.

(Note: Each proposition contains the sentence "This is a property tax increase" because this language is required by law. A bond issue is borrowing money, and taxes must be collected to repay the loan and to cover the interest. However, the district does not necessarily have to collect these taxes through a higher tax RATE. If a district's tax BASE is growing, the district can collect more taxes without increasing the rate, and can sometimes even reduce the rate while still collecting more taxes.)

LOCAL ROUND ROCK INDEPENDENT SCHOOL DISTRICT

PROPOSITION A

Ballot Language

The issuance of \$798,305,000 of bonds for the construction, acquisition, rehabilitation, renovation, expansion and equipment of school buildings (including projects that address facility deficiencies, growth, and safety and security), the purchase of necessary sites for school buildings, the purchase of new school buses and vehicles for emergency, safety, or security purposes, and the retrofitting of school buses with emergency, safety, or security equipment, and the levy and imposition of taxes sufficient to pay the principal of and interest on the bonds. This is a property tax increase.

Explanation

This proposition, totaling \$798,305,000, will provide funding for deferred maintenance throughout the district. Projects are slated for all 56 campuses in the district. It includes repairs to critical systems such as roofing and plumbing, electrical, and HVAC systems. It also includes facility and equipment upgrades and replacements. Portables would be refreshed or removed and classroom additions built. Upgrade plans include ADA upgrades across the district (including playgrounds), replacement of outdated school buses, and safety and security upgrades, including improved fencing, in part to comply with state mandates.

The largest line item is for Round Rock High School's fourth and final phase of renovations. Since its opening in 1971, the campus has grown to meet growing enrollment. Over time RRHS developed into a sprawling campus of separate buildings and inadequate parking, creating security issues that no one could foresee before school shootings became a concern. The proposition includes campus renovations to address these safety and security concerns.

One of the few "growth" projects in this proposal is the purchase and equipping of a new facility for Career and Technical Education (CTE) Programs. The growth in these programs, especially for non-college-bound students, necessitates more capacity. Creating a central facility for the district requires less space and will be less expensive than duplicating facilities at all high schools, although existing CTE facilities at some campuses will remain.

Proposition supporters point out that most of the projects are deferred major maintenance projects, which are necessary to preserve the existing value of the district's investment in its physical facilities. If these repairs and improvements are not made proactively, the district will face increasing numbers of unplanned, costly emergency repairs. These could disrupt instruction and will have to be funded using Maintenance and Operations (M&O) funds, reducing funds available for other district expenditures like teacher salaries, educational programs, and supplies. out that labor and material costs are rising, and that some of these expenditures have been postponed for years.

Opponents of the proposition cite its size and its impact on the district's debt load per student. Some think that more maintenance should be paid for using M&O funds, since this practice would not increase the district's debt, with accompanying debt service costs. Although staff projections indicate that the district can manage this level of indebtedness without raising the I&S tax rate, some opponents are concerned that their taxes will increase.

PROPOSITION B

Ballot Language

The issuance of \$125,300,000 of bonds for the acquisition, improvement and upgrading of technology systems, including related infrastructure and equipment, and the levy and imposition of taxes sufficient to pay the principal of and interest on the bonds. This is a property tax increase.

Explanation

This proposition, totaling \$125,300,000, addresses two major areas of technology-technology infrastructure and instructional technology. Technology infrastructure supports the district's students, teachers, and administrators in their everyday technology use. Infrastructure includes storage systems (servers, data centers), connectivity systems (network cabling, fiber networks, wireless access points), and security devices and software (firewalls, content filtering). Like all types of infrastructure, technology infrastructure needs periodic maintenance and upgrades, and this bond proposal targets these.

Instructional technology devices for staff and students, such as computers, Chromebooks, iPads, printers, and projectors, are vital to modern instruction but also require regular replacement. The state in effect requires all students to have access to individual devices for mandatory state testing. During the pandemic, students were provided with Chromebooks. While these devices are durable and inexpensive, their expected lifespan is about four years. The district plans to replace about a quarter of the devices a year as they reach the end of their life cycle. The district must also periodically replace administrative technology, such as time clocks, cafeteria registers, and phone systems, to provide functions needed for school operations.

Planned regular investment in technology allows implementation costs to be spread systematically and reduces service outages and security vulnerabilities that outdated technology infrastructure can cause. For students and teachers, up-to-date devices prevent the frustration that users often experience when using outdated equipment.

PROPOSITION C

Ballot Language

The issuance of \$8,620,000 of bonds for the construction, acquisition, and equipment of performing arts facilities, and the levy and imposition of taxes sufficient to pay the principal of and interest on the bonds. This is a property tax increase.

Explanation

This proposition, totaling \$8,620,000, calls for a major refurbishment of the Raymond Hartfield Performing Arts Center (PAC) at the McNeil High School campus. The PAC will receive flooring, plumbing, and roof improvement, along with HVAC replacement. Upgrades also include the facility's PA system and fire alarm systems.

The other two large performing arts centers for the district, Cedar Ridge Auditorium and Stony Point Auditorium, need lighting and sound system improvements. Both auditoriums need upgraded infrastructure and instructional technology.

PROPOSITION D

Ballot Language

The issuance of \$65,910,000 of bonds for the construction, renovation, expansion and equipment of athletic stadium facilities, and the levy and imposition of taxes sufficient to pay the principal of and interest on the bonds. This is a property tax increase.

Explanation

Prop D is the only prop with a major "growth item" in the bond.

The district currently has two competition stadiums, Dragon Stadium at Round Rock High School and Kelly Reeves Stadium on the west side of the district. This prop-

Kelly Reeves Stadium needs flooring, plumbing, and roof improvements; furniture replacement; safety and security upgrades; and turf replacement. Dragon Stadium at RRHS also needs stadium renovations and scoreboard upgrades to continue as a competition stadium, but these upgrades, though necessary, will not resolve its capacity, parking, or safety issues, and the stadium's site limits full solutions to these problems. However, the district needs Dragon Stadium as a competition stadium until a new stadium is built.

This proposition designates \$50 million for the construction of a new stadium on A.W. Grimes property owned by the district. Extensive future growth is projected for the east side of the district, where room for substantial population growth remains and is expected because of new semiconductor facilities east of Round Rock.

Proponents of this proposition point out the inadequacy of Dragon Stadium and the impact that the lack of another stadium has on students. Currently, the lack of space necessitates Thursday night football games. This means that hundreds of students and staff are out very late on school nights. A new stadium would provide more flexibility in scheduling for the five high schools and allow for more activities for both middle and high schools to use competition fields and tracks. Proponents also point out that construction costs will not decrease if the project is postponed.

Some who have expressed concern over this proposal indicate that they believe the district does not need an additional competition stadium.



VOTER REGISTRATION CERTIFICATE/CARD

The Voter Registration Certificate/Card provides the district numbers for each race, or you may go to **VOTE411.org**, **https://votetravis.gov** /**current-election-information**/, or **https://www.wilcotx.gov/elections** to receive the list of all candidates you will consider. All citizens wishing to vote must be on the official list of registered voters in their county of residence and provide ID.



ADDITIONAL VOTING INFORMATION

VOTER ID REQUIREMENTS

You must use one of the seven forms of ID to vote:

- ➤ Texas driver license
- > Texas Election Identification Certificate (EIC)
- Texas identification card issued by aDPS
- Texas handgun license issued by DPS
- ► US military identification card with visible photograph
- US citizenship certificate with visible photograph
- ► US passport (book or card)

If you do not have one of the above photo IDs, as a registered voter you can still vote. You will be required to sign a Reasonable Impediment Declaration form and present one of the following documents:

- > Texas voter registration certificate
- Certified birth certificate
- Current utility bill
- Bank statement
- Government check
- > Paycheck
- Any other government document such as an out-of-state driver license or an expired Texas driver license

CHECK ID EXPIRATION DATE:

You can still vote with an expired photo ID. IDs may be expired up to four years. For voters age 70 or older, there is NO limit on ID expiration.

STUDENT VOTERS

Students may use either their parents' address or their college address for voter registration, whichever they consider to be their permanent address. Students cannot be registered in both places. Those who will be away from their permanent address on Election Day and during early voting may request a ballot by mail from their county clerk's office.



Student voters should also know that college or university student photo IDs are not accepted at the polls. Be aware of the general ID requirements.

KNOW YOUR VOTING RIGHTS

- If you are still in line when the polls close, stay in line.
 You will be able to vote past poll closure as long as you stay in line.
- You may ask for another ballot if you have made a mistake.
- If voting machines are down, you may ask for a paper ballot.
- If you run into issues on Election Day, call an Election Protection Hotline.

VOTING SYSTEM

Both Travis and Williamson Counties are now using an Express Vote Ballot Marking Device (BMD), which uses touch-screen technology but produces a paper ballot for tabulation. It is modern, secure, and allows you to verify your selections before casting your vote.

HOW TO VOTE BY MAIL

Any registered voter may vote by mail (VBM) if they:

- are 65 years of age or older (eligible for mail-in ballots for an entire calendar year).
- are sick or disabled (eligible for mail-in ballots for an entire calendar year).
- will be absent from the county during the entire early voting period and Election Day, AND provide an out-ofcounty address where the ballot can be mailed, AND include dates they can receive mail at the out-of-county address (eligible only for one election at a time). Voters who are absent from the county because they are active duty military or because they reside overseas should complete a Federal Post Card Application. Information and forms are available from county and state offices.
- are confined in jail, but otherwise eligible to vote (eligible only for one election at a time).

YOUR VOTE MATTERS



 are expecting to give birth within three weeks before or after Election Day.

The procedure:

- 1. Request the application, which is available for download from the county elections or secretary of state websites, or by calling or emailing the appropriate office. The application is known as an ABBM (application for a ballot by mail). https://www.sos.texas.gov/elections/voter /reqabbm.shtml
- 2. IMPORTANT—The application MUST be completed and received by the early voting clerk in the Travis or Williamson County Elections Division office by October 25, 2024. NOTE: If you submit an ABBM by fax or email, it must also be submitted by mail and received in the appropriate office within four business days of your electronic submission.
- 3. Once received and completed, the mail-in ballot MUST be mailed and postmarked by 7pm on Election Day and received by 5 p.m. on the 1st mail day after Election Day, or if civilians abroad the 5th day after Election Day, or if Military voters the 6th day after Election Day. A VBM tracker and "Cure" process is available at **VoteTexas.gov**.
- Track your VBM application and VBM ballot throughout the election process.
- Provide contact information on your VBM application so the county may contact you if you need to fix an error with your application or ballot.
